This distinguished veteran, now conquer- ed by the one unconquerable foe, who faced danger after danger, and engaged in battle after battle, after having been an eye witness to the most heart rending and thrilling scenes of the monster War, has since his last great victory on the field of Waterloo, addressed the House on subjects of the highest moral tendency. This passing of the Catholic Emancipation Bill with an acuteness and determination worthy of a younger man, amidst such contending animosity is highly creditable. Having the welfare of his country at heart, he fought like his contemporary Napoleon, regardless of personal danger, and shared with those under his command, the fatigues, dangers, and distress connected with the punishment of his immortal campaigns.

Wellington, though he engaged in War detected it from his heart, and looked upon it with as much abhorrence, as such an utter disregard of the Divine Laws should be created in the minds of civilized men reframed from needlessly spilling human blood, and openly concurred with Cobden and Eliot Burritt the great peace advocates, in the necessity of endeavoring, if possible, to bring about a method for the adjustment of national differences, without recurring to the barbarous resource still in vogue. "The Hero of a hundred fights," notwithstanding the unmangled and almost idolizing eulogy with which he was greeted, attended reluctantly to his devotions, and thus completely ruined the deeds of a great and good man, a wise and distinguished Statesman, and a discreet and valiant general.

The Assizes for the United Counties of Huron, Perth, and Bruce, were opened at Goderich, on Monday the 27th inst., by the Honourable Archibald McLean, Colonial Prince commanding Queen's Counsel.

Judge McLean, uniformly with views expressed by himself when last in Goderich, refused to hold the Court in the new County chamber except for other purposes, in the upper story of the Gaol, and adopted in its stead the large room recently added to the Birch Exchange Hotel, which was temporarily fitted up for the occasion. The Courts are much in want of a Court House, year after year, and suffice after assize, the deficiency has been felt and discussed. We hope that, as well as many other equally, if not more important and necessary improvements, will before long, be effected, through the active exertion of our County Council, who, we trust, will be encouraged and supported in the fulfillment of their difficult engagements by the rest of the people.
