The Citizenship Act is Amended!

On February 15, M.P. Bob Pennock's Private Member's Bill C-254 was proclaimed. Exactly 11 years earlier the Citizenship Act was amended excluding a similar provision which had been contained in the previous Act. For your information the complete text of Bill C-254 follows:

BILL C-254

An Act to amend the Citizenship Act (period of residence)

Her Majesty, by and with the advice and consent of the Senate and House of Commons, enacts as follows:

- 1. The *Citizenship Act* is amended by adding, immediately after subsection 5(1) thereof, the following:
- "(1.1) Any day during which an applicant for Canadian citizenship resides with his or her spouse who is employed outside of Canada in or with the Canadian armed forces or the public service of Canada or of a province,

otherwise than as a locally engaged person, shall be treated as equivalent to one day of residence in Canada for the purposes of paragraph (1)(b) and subsection 10(1)."

2. This Act shall come into force on a day to be fixed by proclamation.

To celebrate the proclamation of Bill C-254, the Foreign Service Community Association held a reception honouring the author of the Bill, Mr. Bob Pennock, P.C., M.P., and Senator Peter Bosa who sponsored the Bill in the Senate.

We are all delighted with the change this Bill has brought about.
