THE IMPERIAL CONFERENCE OF 1911.

On the Orders of the Day being called:

Sir WILFRID LAURIER: Mr. Speaker, I would like to call the attention of my right hon. friend the Prime Minister (Mr. Borden) to the speech delivered by him on the 7th of April. He made a statement which I did not notice at the time, or my attention was probably called elsewhere; but I could not help noticing it when I read it. It will be found at page 7414 of My right hon. friend said: Hansard.'

And that brings me to another considera-tion-the right hon. gentleman is concerned about the representation of Canada on the Imperial Defence Committee. As I under-stand it, the right hon, gentleman himself agreed that Canada ought to be represented on the Imperial Defence Committee,-

Which, of course, is very true. (Reading):

-and further than that-although I did not know it until last summer, the matter was kept entirely confidential at the time, for what reasons I do not know-the right hon. gentleman agreed to establish a defence com-mittee in Canada in close co-relation with that Imperial Defence Committee.

That is perfectly true; we agreed to that at the last Imperial conference. (Reading):

No announcement of that kind was made to Parliament by the right hon. gentleman at the time we might have expected the an-nouncement to be made, and it remained for the Colonial Secretary a few weeks ago to make that belated announcement, as the right hon. gentleman had not seen fit to do 80.

That is the point to which I desire to draw the attention of my right hon. friend. I do not know what he means when he says that I did not bring that matter to the attention of the House. May I ask him what he refers to?
