## GERM WARFARE EXPERIMENTAL STATIONS

**Question No. 297—Mr. Matheson:**

Does the government operate a germ warfare experimental station or stations and, if so, where, why, and what is the total cost of these operations during the last three years?

**Answer by: Mr. Harkness:**

The defence research board of the Department of National Defence has a program of research to evaluate the hazard to service personnel and to civilians from attack by biological agents, and to develop means of detection and prophylaxis and therapy against such agents. This program is carried out at Suffield experimental station in Alberta, and at defence research chemical laboratories in Ottawa and defence research Kingston laboratories.

For security reasons the information regarding the cost of these operations cannot be divulged in greater detail than in the estimates.

## \*INVESTIGATIONS OF FOREIGN FISHING BOATS

**Question No. 300—Mr. Robichaud:**

Were any searches or investigations made by fisheries officers on foreign registered trawlers or seiners operating in the gulf of St. Lawrence or bay of Chaleur area from April 1, 1962, to date and, if so (a) on what dates were such patrols or searches carried on (b) have any violations been reported and, if so, what was the nature of such violations (c) what action has been taken by the fisheries department to protect Canadian fishermen against such operations?

**Mr. MacLean (Queens):** Mr. Speaker, assuming the second last word in the first line to be "for" instead of "on", the answer is yes. No investigations or searches were made in the gulf of St. Lawrence or bay of Chaleur areas actually on board any foreign registered trawlers. The answer to part (a) is July 18, 19, 20, 23, 24, 25, August 28 and September 5, 6 and 15. The answer to part (b) is no. The answer to part (c) is: A fleet of patrol vessels is operated on the Atlantic seaboard, part of the duties of which is enforcement of the provisions of the Coastal Fisheries Protection Act. Reports of contraventions of the act are promptly investigated. Air patrol is used, where necessary, to supplement the work of the water patrol.

## \*WINTER WORKS PROGRAM, MARITIME PROVINCES

**Question No. 301—Mr. Rideout:**

Will the government consider including hospital and school construction in the winter works program to help relieve unemployment in the maritime provinces?

**Mr. Hales:** The scope of the municipal winter works incentive program has been broadened from time to time so that it now includes any capital undertaking of a municipality

except work on schools and school grounds, hospitals and hospital grounds, subway transportation systems and municipally owned buildings used for industrial or business purposes under private auspices.

The federal government is making substantial contributions to the provinces in respect of certain phases of education as well as towards hospital construction and it is not intended at this time to further broaden the scope of the municipal winter works incentive program.

## WORLD HEALTH ORGANIZATION

**Question No. 302—Mr. Marcoux:**

1. Is Canada contributing financially to the world health organization?

2. Has Canada authorized the world health organization to promote water fluoridation in the city of Ottawa?
