QUEBEC—INTERPRETATION OF FEDERAL GOVERNMENT CONCESSION RESPECTING CERTAIN COST-SHARING PROGRAMS

Hon. Martial Asselin (Charlevoix): Mr. Speaker, I wish to ask a question of the Minister of National Health and Welfare.

We are told that at the federal-provincial first ministers' conference, the federal government has agreed to increase special abatement points for Quebec from 22 to 24 in connection with hospitalization and health insurance programs. Can this concession be taken as a sign of recognition by the federal government of a special status for Quebec, at least in the fields which I have just mentioned, as was indicated yesterday by the Quebec premier at a news conference?

Hon. John C. Munro (Minister of National Health and Welfare): No, Mr. Speaker. There were previous arrangements with Quebec relative to hospital insurance dating back to 1964. These are not changed. The province does not operate under the system of tax points with reference to medicare, as the hon. member knows. The health proposals which were discussed with the provinces had to do with a new formula based on a per capita assessment and did not involve the equalization formula per se.
