VETERANS LAND ACT

AMENDMENT TO EXTEND DEADLINE FROM MARCH 31, 1974 TO MARCH 31, 1975

Mr. Peters: Mr. Chairman, before the supper break I was pointing out that much of the good legislation that applies to the Farm Credit Corporation is the result of the excellent work that was done for veterans legislation in the area of agriculture. Prior to that, the legislation for farm credit was so bad and the Farm Loan Board had got into so much trouble that the ideas behind the Veterans Land Act were applied to new legislation for the Farm Credit Corporation. I was also pointing out that there was a lesson in the VLA and the small holding legislation that could be applied to the housing situation. There are a number of features in the legislation that would have done a great deal not only for veterans but for all Canadians. While there are some advantages for veterans, one of the major clauses provides that veterans must make Canada their full-time residence and they must be residents for a period of ten years. This of course, applies to other things as well.

One of the sad things about the legislation before us is that it probably covers the least that could be done. I know that is not what the minister intends and I am sure it is not what the hon. member for Humber-St. George's-St. Barbe intended. I think it is safe to say that it is not what any member of this House wants for veterans under the VLA. If the bill included three major things it would probably receive quick passage tonight.

In my opinion, Mr. Chairman, dates should be totally removed from the bill. As I pointed out before, I was one
