OLD PORT OF QUEBEC

Under these circumstances and in view of the comments we had received from various quarters, I suggest that a full assessment of the administration of these projects was urgently required in the public interest, and so I ordered one made and I have so decided; I hope I can table within the next few months a full investigation report, so that the general public may find out why and how public funds were spent.

EMPLOYMENT

PROVISION OF JOB-CREATION FUNDS

Mr. Lorne Nystrom (Yorkton-Melville): Mr. Speaker, my question is directed to the Minister of Employment. I am sure she shares my dismay that some senior business executives said on *The Journal* last night that the Government's confidence building program will not create many jobs for at least one year. In light of the fact that the Minister confirmed in committee yesterday that the \$1 billion which has been allocated for creating jobs will not, in her words, be made up of any new money whatsoever, could the Minister go to the Prime Minister and to the Cabinet to see whether or not they will allocate several billion dollars to create jobs in the immediate term?

Hon. Flora MacDonald (Minister of Employment and Immigration): Mr. Speaker, the Hon. Member will know that since I came into office, a short period of just over two months, we have allocated \$430 million for direct job creation this winter. That means some 70,000 jobs are to be created. We have also re-allocated \$1 billion from other programs to job creation and new job opportunities. I would think that the allocation of \$1.5 billion toward job creation, new job opportunities and human resource development, in just over two months is really a pretty good record.
