INCOME TAX**DEFERRED CORPORATE TAXES—GOVERNMENT POSITION**

Mr. Mike Cassidy (Ottawa Centre): Mr. Speaker, my question to the Minister of Finance relates to the impact of tax reform on the \$28 billion's worth of deferred taxes owed the Canadian Government by Canadian Corporations, since a 20 per cent reduction in the corporate tax rate could put \$6 billion in the pockets of those corporations.

We know that where a Canadian would have taxes owing Revenue Canada, he would pay the full 100 per cent. Would that policy apply to corporate deferred taxes, or does the Minister intend to retroactively grant corporations a tax reduction worth \$6 billion?

Hon. Michael Wilson (Minister of Finance): Mr. Speaker, it would be helpful if the finance critic for the New Democratic Party were to collaborate with his Leader before Question Period, because that is the precisely the same question that his Leader just put to me.

Mr. Cassidy: Mr. Speaker, my simple reason for asking the question is to determine whether deferred corporate taxes will be paid in full, or whether the Government intends to give a retroactive tax cut to corporations through a corporate tax cut which would apply to deferred taxes.

POSSIBLE EFFECT OF TAX CUT ON CORPORATIONS

Mr. Mike Cassidy (Ottawa Centre): Mr. Speaker, taking three companies alone, Canadian Pacific, Bell Canada, and Imperial Oil, they have among them \$5.4 billion of deferred taxes sitting on their books.

Some Hon. Members: Question.

Mr. Cassidy: If the tax rate on corporations is cut by 20 per cent, those companies will realize a windfall of \$1 billion by way of tax savings.

NUCLEAR ENERGY**REPORTED DESIGN FLAWS IN UNITED STATES PERRY NUCLEAR GENERATING STATION**
