handed over to Canadian authorities. Does the Minister share the view that alleged rape is not a serious enough crime to force apprehension of a suspected rapist?

Right Hon. Joe Clark (Secretary of State for External Affairs): Mr. Speaker, I of course do not share that view nor, I imagine, do the people the Hon. Member presumes to quote. The facts of the situation are that, in accordance with the strict interpretation of international law, the U.S. naval commander involved took back on board ship the alleged perpetrator of this act. That is in strict accordance with law. It is not, however, the normal practice.

The recourse open to us would be to trigger extradition proceedings. That can only be done in response to a request by the Government of the Province of British Columbia. If we receive such a request, we will act upon it.

PROTECTION OF CANADIAN CITIZENS

Ms. Margaret Mitchell (Vancouver East): Mr. Speaker, I am pleased with the Minister's response and his prompt action. As he knows, rape is a criminal offence in Canada.

I wonder what action the Minister would take immediately with the British Columbia Government to ensure that other visiting sailors are not above Canadian law and that our citizens are protected under our laws.

Right Hon. Joe Clark (Secretary of State for External Affairs): Mr. Speaker, we will make the necessary contacts with the British Columbia Government and, in addition to that, we will remind American naval commanders and commanders of other vessels that might dock in Canadian ports of the usual practice, which was not followed in the case to which the Hon. Member makes reference.

FUTURE OF FIRESTONE PLANT IN HAMILTON

Ms. Sheila Copps (Hamilton East): Mr. Speaker, my question is for the Deputy Prime Minister and concerns the potential loss of 1,300 jobs at a Firestone plant in Hamilton that only four short years ago received \$13.5 million in federal funding. Three weeks ago the Minister said he was on top of the dossier. He will no doubt be aware that, as of this moment, management at Firestone is preparing to have some of its machinery taken out of the Hamilton plant and shipped off to Des Moines, Iowa.

Is the Deputy Prime Minister prepared to move immediately to force Firestone to cease any attempt to remove any equipment from that plant until we have had a chance to do an assessment of just how much of that machinery comes from

the federal Government's \$13.5 million, or is his promise that the dossier is being looked after just more idle talk like the Moncton shops promise he made to the workers in Moncton?

Hon. Don Mazankowski (Deputy Prime Minister and President of the Privy Council): Mr. Speaker, on behalf of the Minister of Regional Industrial Expansion I will take that question as notice. Perhaps with her connections with the Liberal Government in Ontario, the Hon. Member may want to make representations there as well. I think in fairness that there is a certain responsibility for this matter that could be levelled on its shoulders as well.
