

SPECIAL FUND FOR THE AGED

Cent a Month From Each Member of the I.O.F.—The New Rates.

Toronto, June 19.—An arrangement has been made for the creation of a special fund to take care of the needy old members of the I. O. F. by the Stevenson plan. This will be a levy of 1 cent a month from each member, amounting to over \$20,000 a year.

By a vote of 123 to 54, the following resolution on rates was carried: "That old members be re-rated as of age of entry, as set out in the S. C. R. report, such re-rating to start on Oct. 1, 1908, with the option set out in S. C. R. report, as option A, or a new option to borrow from month to month the additional premium required, the same to be charged, with 4 per cent interest, against the policy, as alien thereon; also that the same provision regarding extra assessments contained in plan of the committee be adopted.

"That the executive arrange to ascertain the experience of the I. O. F. for twenty years or upwards, and report at the next special or regular session of the supreme court, and that the committee on constitution and laws be instructed to report the necessary amendments to effectuate this recommendation."

This is a compromise between the Stevenson and Myers proposition. The new arrangement is that known as the 1895-98 scale and covers 10 to 64; option A allows for reduction of policy to carry at the present premium paid. The new table is an average increase of 65 per cent.

The propositions laid before the supreme court were:

1. To bring the rates of the "old" members up to those paid by "new" members since 1895, without payment of arrears.

2. Adoption of a new rate (Mr. Stevenson's plan), allowing for a somewhat higher rate for the future, and an option added to make up for the lower rates in the past. This proposition is coupled with option A to reduce the arrears of the policy, keeping the rates the same as in the past, and an option in addition to or in substitution of option B permitting the member to borrow from the accumulated funds to entitle him to the order at interest on the security of his certificate, the monthly difference between his old rate and his new rate to enable the member by such borrowing to carry the full amount of his insurance.

3. The re-rating of the members of the order on the basis of the national fraternal congress table of rates for the I. O. F. benefit at attained age, giving to each member such reduction in his rate as such member's pro rata share of the accumulated funds would entitle him to. This proposition is complete with similar options given under the second proposition.

The first provides for the lowest rate; the second is more stringent, and the third the most stringent. The first two provide for the future, and the last would increase both classes.

In the first the "old" and "new" members would pay the same for the future; in the second the "old" would be paying more; in the third, both would be paying the same, but higher rates than by the first.

The salary of the supreme secretary was reduced to \$2,000 and of the treasurer to \$2,000.

Burns. Mr. Brodie responded on behalf of Mrs. Brodie and himself in fitting terms. The proceedings were also enlivened with an excellent programme. Timely addresses were given by Messrs. William Watcher, A. A. McCullum, D. R. Stirling, John McCullum and Rev. J. C. Burns. John Noble sang a patriotic song and a choice luncheon was served by the ladies.

PAPER MILL BURNED

ESTIMATED LOSS \$30,000

Lincoln Paper Company's Plant at St. Catharines Destroyed.

St. Catharines, June 19.—This morning nearly one of the mills of the Lincoln Paper Company, situated on the Welland Canal, was totally destroyed by fire. The loss will reach probably \$30,000. Insurance about half that amount.

The cause is a complete mystery, though it may be laid at the door of friction. The expensive machinery used in making paper is ruined, officials of the company declare. About twenty men were employed in the mill. It is not sure that it will be rebuilt.

FARMER'S HORRIBLE DEATH.

Norwood, June 20.—A farmer named Orbin Colby, living about eight miles north of here, and employed at Parker's Mill, was coming to Norwood with a load of lumber, when the neckyoke broke coming down a hill. The wagon upset, and the unfortunate man was horribly crushed under the load, and died in a few minutes. He leaves a widow and large family of small children.

BLACK HANDERS MEET THEIR FATE

Severe Blow Dealt the Gang in New Orleans By Their Intended Victim.

New Orleans, June 18.—A severe blow was given the Italian Black Hand early this morning when three members of that criminal organization were killed, and another mortally wounded by Pietro Giacomina, a wealthy Italian wine merchant, when they were trying to blackmail him. It was supposed that the Black Hand had been crushed out a year ago after the murder of the Lamano child, when many members were arrested, convicted and sentenced to be hanged or to the penitentiary for life and when the Italians organized a vigilance committee which was to ferret out these murderers and protect all Italians threatened by them.

From this false security the public was aroused last week by the dynamiting of the residence of a well-to-do Italian merchant of the name of Serio. It then developed that the Black Hand was more actively at work than ever that Serio and others had been compelled to give up their money under threats of murder, dynamite or kidnapping of children, that they had reported those threats to the vigilance committee, but not to the police, and had received no protection.

Among the victims was Pietro Giacomina, who has paid a monthly sum to the members of the Black Hand not to be troubled by them. Giacomina is a wine merchant, wealthy, occupying one of the most famous old French residences in New Orleans, the Beauport house, the birthplace of the famous confederate General Beauregard.

Last night four members of the Black Hand who have been in the habit of collecting this tribute called on the wine merchant. He invited them into the house and they drank together. Giacomina says that they demanded an increase in the tribute and on his refusal threatened the life of his son, drawing pistols on him and his wife. Giacomina was evidently prepared for the trouble for he seized a rifle and opened fire on the men. When the neighbors rushed into the house it was to find three men dead and one dying.

The dead were John Baracca, a truck farmer from the upper court, suspected of black handism and involved in the Lamano kidnapping and murder case; an Italian supposed to be a barkeeper, Vroilles, and Schero Cusimano, a recent arrival from the country. The mortally wounded man was Francesco Vitale, only eight days from St. Louis. Vitale's case is peculiar as he claims to have been struck by a bullet passing the house and into the back of his head.

The police insist he is the fourth member of the party that visited Giacomina's house to blackmail him and that Giacomina is trying for some personal reason to protect him.

SHARKEY COULDN'T GET ARRESTED

Tried in Vain To Surrender After Fatal Fight at League Island.

Philadelphia, June 21.—William Sharkey, of 727 Jackson street, known in boxing circles as "Johnny Hogan," whose terrific punch knocked out Peter G. Hagan, a marine, in the third round of a bout on board the battleship Mississippi, at the League Island Navy Yard late on Wednesday night, his opponent dying nearly an hour afterwards, vainly visited the police of the Fourth street and Snyder avenue station, the district attorney's office, the United States district attorney's office, the coroner's office and the central police court yesterday in an effort to have himself arrested.

Neither the Government nor local authorities showed any disposition to take the young fighter into custody; the consensus of opinion being that he was blameless, although the tragic end of the marine was most unfortunate. Sharkey was much affected by the sad termination of the bout, and he said he did not think he would ever enter the ring again.

Rear-Admiral Pendleton, commander of the navy yard, appointed Lieutenant Commander John L. Witt and Surgeons Oliver Diehl, J. B. Dean and H. O. Shiffert as a board of inquiry to investigate the death of Hagan, and whatever findings they reach will be communicated direct to the secretary of the navy.

Hagan's Condition.
Dr. B. D. W. Brownell, surgeon of the Mississippi, denied emphatically yesterday that Hagan was in a poor physical condition when he donned the gloves on Wednesday night.

"Hagan was examined carefully by me before he entered the ring," the surgeon said, "and he was in good condition. Had he not been you may be sure that I would not have permitted him to fight."

He and Sharkey fought a six-round "go" a month ago and were well matched. There was a friendly rivalry between them. The only thing that he had a boil on one of his legs, but it was not serious. He must have had some affection of the heart, the doctor received must have caused the nerve of that organ to contract. The blow was struck at 9:45 o'clock, and he died at 5 minutes past 11 o'clock.

Hagan's comrades at the Navy Yard barracks said that he had recovered recently from a two weeks' illness, but had insisted that he was well enough to fight Sharkey.

"Besides, I don't want to disappoint you boys," he remarked, and he pluckily trained for the bout, which cost him his life. His home was in Chicago to which place his body has been sent. He had been in the Marine Corps for three years and had a ready gained quite a reputation in the navy as a boxer.

Sharkey Visits Police.
Sharkey arose early in the morning and went to the Fourth street and Snyder avenue police station. There he met Special Policeman McCollough and offered to surrender himself. McCollough took him to the city hall, where the young boxer was interviewed by Coroner Jermon, Superintendent of Police Taylor and Magistrate Beaton.

The three officials looked up the law governing the matter and they quickly decided that they had no right to arrest the boxer, as the tragedy had occurred on Government property. Sharkey was not satisfied, however, and insisted upon going to District Attorney Rotan's office. The latter confirmed the decision of the officials, but even then Sharkey still remained worried.

Sharkey Sorry.
"No one is more sorry than I am for Hagan," he said, "and if I should be arrested and even imprisoned I would rather it would happen than to have any one say that I tried to dodge punishment. I don't remember hitting the boy over the heart. It looked to me like a clear case of exhaustion. I didn't hit him hard enough at any time to hurt him seriously."

Sharkey then went to the United States district attorney's office in the Postoffice Building. From there the commandant's office at the Navy Yard was contacted with and soon word came over the wire that Sharkey was not wanted by the authorities.
