Mr. MacBeth, one of the parties appointed by last Synod to support the overture anent an Assembly General Committee, before the General Assembly, made a verbal statement anent the action of the Assembly in respect to the overture. It was agreed to receive Mr. MacBeth's report, to thank those appointed to support the overture for their diligence and to call the attention of the Presbyteries to the remit sent down by the Assembly in the case.

Prof. Baird reported for the Committee in the Geddes case submitting an overture to the General Assemby requesting additional assistance for Mr. Geddes from the Aged and Infirm Ministers' Fund. The overture was adopted, and the Committee was instructed to secure all the documents in the case and transmit with the overture to the General Assembly. Prof. Baird and Mr. Carmichael were appointed to support the overture before the General Assembly. Dr. Bryce, for the Convener of the Augmentation Committee, submitted a statement of the general condition of the Augmentation Scheme in so far as this Synod is concerned. The statement was received.

The attention of the Synod having been called to the fact that notice had been received of several bequests to various bodies in the Northwest, it was agreed, on motion of Dr. King duly seconded, to appoint a Committee of three to take such action as may be necessary to protect the interests of the Church in the matter; the Committee to consist of the Moderator, Dr. King and Dr. Bryce.

It was agreed on motion of Mr. Rumball, seconded by Prof. Baird, that the clerk be authorized to call for the reports of Committees and other documents to come before the Synod, to be submitted to him at least eight days before the meeting of Synod—that the Committee on Arrangements be authorized to spend up to fifty dollars in having the reports, or such of them as may seem necessary, printed in time for the meeting of Synod, and to arrange for railway rates, and that the Committee on Equalization of Expenses be authorized to issue a circular to all members of Synod explaining the equalization scheme, and giving assurance that it has been definitely adopted for the next Synod.

It was further agreed on motion of Mr. Rumball, duly seconded, that the Treasurer be instructed to pay the sum of Ten Dollars to the Caretaker of Knox Church for his services during this meeting of Synod.
