

PURCHASER'S REMEDIES—(Continued).

- contract—unless vendor had declared whole purchase money due, 160.
- damages in lieu or in addition to specific performance, 161.
- decree, typical form of, 161.
 - suggested from where all instalments not yet matured, 162.
- contract disaffirmed,
 - (a) rescission by purchaser
 - general principles same as discussed, chapter III., 163.
 - rescission distinguished from repudiation, 129, 163-166, 170.
 - purchaser's *repudiation* for defects in vendor's title good defence to vendor's action for specific performance, 165.
 - but *semble*, not equivalent to rescission, 165, 166.
 - repudiation for defects in title, right of waived by delay, 166, 167, 170, 182.
 - knowledge of defects includes constructive knowledge, 170.
 - how far waived by taking possession and paying instalments, 156, 171-173.
 - right of rescission may continue though right of repudiation gone, 171.
 - aliter* where purchaser's acts amount to acceptance of title, 172.
 - purchaser entitled to recover deposit and purchase money on rescission, 175.
 - but not to damages as well, 175.

RECEIVER,

- may be appointed by decree or interlocutory order to preserve vendor's lien, 43.
- may be appointed by decree or interlocutory order to preserve purchaser's lien, 175a.

REGISTER,

- under Torrens system, takes place of abstract, 156, 170, 171.
- constructive notice of, 171, 173, 174.
