STRENGTH OF FENIANISM

Sudden Alarm at Windsor Castle.

Threats Against a Branch of the Fenian Brotherhood—Violence, Intimidation and the New Fenian Tactics.

LONDON, April 23.—The Times says the government has obtained information in recent inquiries that the enrolled membership of the Fenian organization in the United Kingdom numbers 150,000, and are besides distinct outfits of Fenians, such as the vigilantes and inviolables, Kingston, who was arrested in Liverpool, belongs to both of these branches.

Such double membership is unusual. There is besides a secret society affiliated with the American dynamite party. The Fenians have accurate information regarding the movements of the coast-guarding the coast of Ireland, and it is reported that Fenian boats and their crews have been received by officers of the coast-guard at various points.

The Fenians are reported to be in possession of a large quantity of dynamite, and it is believed that they are preparing to make an attempt to blow up the Fenian building in London.

A WEDDING DAY CLOUD

SIR JOHN A. MACDONALD SUMMONED FOR PERJURY.

General M. Butt Henson still pursues the Premier and swears out a subpoena—A Fetter Around Town.

Gen. M. Butt Henson went before Magistrate Denison yesterday morning and swore out a subpoena charging Sir John A. Macdonald with perjury.

When it became known that this subpoena had been taken there was a great flutter round headquarters and the court house.

The papers in connection with the information were closely guarded by the clerk of the police court, Mr. Nadel, who would not divulge in any way the nature of the subpoena.
