## IMPORT DUTIES INCURRED BY E. J. BENSON

That an Order of the House do issue for a copy of all correspondence, official notices, and other relevant documents since April 30, 1965, relating to custom duties incurred by Mr. E. J. Benson, 119 McMichael St., Kingston, Ontario, on any goods imported by him into Canada.

**Hon. E. J. Benson (Minister of National Revenue):** In view of the fact that I have already provided the hon. Member and the House with more information than is required in the motion, and in view of its implication with regard to the privilege attaching to correspondence between my Department and individual taxpayers, I respectfully request that the hon. Member withdraw this motion.

**Mr. E. Nasserden (Rosthern):** I was quite surprised when I first brought this motion forward that the Minister should have asked me to withdraw it before it appeared on the order paper. The answers which have been given in the House so far do not engage those aspects of the matter in which I was interested; therefore I should like the motion to be proceeded with.
