ALLEGED FREE BUS TRANSPORTATION FOR TRANSIENTS—CONSIDERATION OF PROGRAM BY HOUSE

REGIONAL ECONOMIC EXPANSION

MONTREAL—APPLICATION BY CITY UNDER AMENDED INCENTIVES ACT

Mr. James A. McGrath (St. John's East): I wish to direct a question to the Minister of Regional Economic Expansion. Are any applications pending or currently in the process of being approved from the city of Montreal under the recent amendments to the Regional Development Incentives Act?

Mr. Speaker: Order, please. That, of course, is not a point of order. The hon. member is arguing the urgency of the matter. The Standing Order is designed to cover this type of situation. If the hon. member thinks there is urgency, his recourse is to suggest that the matter be considered at the time of adjournment.

GOVERNMENT ORDERS

PENSION ACT AND CIVILIAN WAR PENSIONS AND ALLOWANCES ACT

PROVISION OF INCREASES IN BENEFITS

Hon. Jean-Eudes Dubé (Minister of Veterans Affairs): moved that Bill C-203, to amend the Pension Act and the Civilian War Pensions and Allowances Act, be read the second time and referred to the Standing Committee on Veterans Affairs.

Mr. Speaker, just over a year ago I had the privilege of making public a white paper on veterans pensions, setting forth the views of the government on the recommendations of the Woods Committee for amending the Pension Act. The white paper was extremely well received, both by veterans and the general public. I am delighted to be speaking at this time on a bill designed to incorporate into the Pension Act almost all of the proposals we made in the white paper. Some have been amended, some have been expanded and several have been enriched.

On December 2 last, this bill was tabled in the House for first reading. It was most satisfying to read in the press the next day that the National Association of Veterans Organizations had expressed its satisfaction with
