POLLUTION—BANNING OF PHOSPHATES

Question No. 1,497-Mrs. MacInnis:

How many letters, telegrams, signed protests or other communications were received by the Minister of Energy, Mines and Resources from January 15 to February 28, 1970, demanding legislation to ban phosphate detergents?

Mr. R. J. Orange (Parliamentary Secretary to Minister of Energy, Mines and Resources): Between January 15 and February 28, 1970, the Minister of Energy, Mines and Resources received 413 letters, telegrams, signed protests or other communications concerning legislation to ban phosphate detergents.

Has the Government of Canada arrived at a decision as to whether it will construct a causeway to Lennox Island and (a) if so, when will construction commence (b) if not, how soon may one be expected?

Mr. Russell C. Honey (Parliamentary Secretary to Minister of Indian Affairs and Northern Development): No, the construction of a causeway to Lennox Island is still under consideration. It is not possible to forecast when a decision will be made.
