**UNEMPLOYMENT INSURANCE****NUMBER OF EMPLOYEES FOUND TAMPERING WITH CLAIMS

**CANADIAN BROADCASTING CORPORATION****REQUEST OF REGIONAL PRODUCERS FOR INVESTIGATION OF  
TORONTO DOMINATION—MOTION UNDER S.O. 43**

**Mr. Benno Friesen (Surrey-White Rock):** Mr. Speaker, I rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity. On Friday, June 4, a large and responsible body of Canadian Broadcasting Corporation television producers from all parts of Canada called for the government to establish a royal commission to study the Toronto domination of the English network. Mr. Speaker, these people have been reluctant to express their concern outside of the family circle of the CBC, but because the problem is a long standing one and is not being attended to quickly enough, these producers from all parts of Canada have made the public call for action.

In view of the fact that the House has already given unanimous consent to have another matter similar to this referred to the Standing Committee on Broadcasting, Films and Assistance to the Arts, the matter being the elimination of regional farm broadcasts, and in view of the

fact that these producers believe, with good evidence to support this belief, that the CBC's neglect to involve regional producers when promoting a national viewpoint is in fact a violation of its charter, I move, seconded by the hon. member for Oxford (Mr. Halliday):

That this House instruct the government to honour the request of the CBC television producers from all parts of Canada for a royal commission to study the Toronto domination of the English network.

**HOUSING****REQUEST FOR AID IN REBUILDING PORTION OF MAIN À DIEU  
DESTROYED BY FIRE—MOTION UNDER S.O. 43**

**Mr. Andy Hogan (Cape Breton-East Richmond):** Mr. Speaker, I rise under the provisions of Standing Order 43, on a matter of urgent and pressing necessity.

On this past weekend, as the national news has recorded, there has been a significant tragedy in the historic fishing village of Main à Dieu on Cape Breton Island. Seventeen homes, plus the Roman Catholic Church in the area, were wiped out by a devastating fire. In view of the seriousness of the situation, I move, seconded by the member for Nickel Belt (Mr. Rodriguez):

That officials of the rural and native housing section of the Central Mortgage and Housing Corporation, be immediately sent into the area to get new housing started for the families involved and cut the red tape to a minimum; also, that the Minister of State for Fisheries immediately implement the project for a breakwater extension in Main à Dieu that was to be carried out in the 1977-78 small crafts and harbour program.
