NATIONAL DEFENCE

PURCHASE OF FIGHTER AIRCRAFT

Mr. Allan B. McKinnon (Victoria): Mr. Speaker, in the absence of the Minister of National Defence I will direct my question to the Prime Miniser. Can the right hon. gentleman confirm that the new fighter project management office has recommended that a short list of three planes be considered for the impending fighter contract—the F-16, the F-18A and the F-18L?

Right Hon. P. E. Trudeau (Prime Minister): I am not sure what the hon. member is quoting from. It is certainly not government policy.

Mr. McKinnon: I was not quoting from anything at that point except my own question, Mr. Speaker. Perhaps the Prime Minister has noted the following quotation from a Canadian Press release:

"One of the options the cabinet is considering is a so-called short list dropping some of the competing firms", Danson said.

Could the Prime Minister tell the House whether the choice is being dictated entirely by the fact that these three planes are the cheapest of those under consideration and that since only a fixed sum of money is available—\$2.3 billion in 1977 dollars—other important factors such as air superiority qualities, range, and target acquisition capability all have to be sacrificed in favour of financial considerations?

Mr. Trudeau: The question is purely hypothetical. However, I can tell the hon. member that we want to try to get the best plane for the least money.

FARMING METHODS—BEEF IMPORT QUOTAS

Mr. R. E. McKinley (Huron-Middlesex): Mr. Speaker, the largest show of its kind in the world, the International Plowing [Mr. Speaker.]

RESTRICTION ON ONTARIANS WORKING IN QUEBEC

Mr. Jean-Robert Gauthier (Ottawa-Vanier): Mr. Speaker, my question is directed to the Minister of Employment and Immigration: it concerns the impending application by the province of Quebec of restrictive labour regulations preventing, as of July 1, many Canadian tradesmen from working in Quebec. Is the hon. gentleman consulting with his colleague, the Minister of Labour, with a view to supplying this House with statistics showing the effect of this move on, for example, mobility grants which constitute an important program in his department, and will he tell us what decision he has taken to ensure interprovincial mobility in light of the socioeconomic impact the regulations may have on border communities?

Hon. Bud Cullen (Minister of Employment and Immigration): This issue has also been raised by the Parliamentary Secretary to the Minister of Finance since the proposal would have a particularly detrimental effect on people who live in Cornwall and along the border. It would certainly have a negative impact. I believe the Prime Minister indicated on Friday that we are opposed to action of this kind being taken, and I believe he also said he was awaiting an opinion from the Department of Justice. We do make mobility grants available to workers moving both ways. I will get the figures for the hon. member.
