HYDROELECTRIC POWER—EXAMINATION OF ALCAN PROJECT IN B.C.

Mr. Lorne McCuish (Prince George-Bulkley Valley): Madam Speaker, in the absence of the Minister of the Environment I will direct my question to the Deputy Prime Minister.

The Aluminum Company of Canada remains determined to embark upon the second phase of its Kemano hydroelectric development project in central British Columbia, a program which will cause devastating ecological and environmental damage over a wide area. On April 28 the minister informed this House that he had the assurance of the province of British Columbia that this program would not be proceeded with until a full public inquiry had been held.

At that time, Madam Speaker, I urged that the minister go to British Columbia to see for himself exactly what would happen. I now urge that he remain behind, because if he should go he will come back in a Glad bag.
