REGIONAL ECONOMIC EXPANSION

AID TO DEVCO COAL MINE—INSTALLATION OF FIRE DOORS

Hon. Michael Wilson (Etobicoke Centre): Mr. Speaker, my question is directed to the Minister of Regional Industrial Expansion and it relates to the support that the Government announced last week for the Devco mine and the closure of No. 26 Colliery, an announcement which we on this side of the House welcome. However, I am sure that the Minister is aware of the concerns that have been expressed regarding the safety of the mine, and of the hope that has been expressed that this type of disaster will not recur.

Since Colliery No. 26 experienced a series of fires over the years, some of which caused fatalities, there have been recommendations for the installation of fire doors in the mines to control fires. Would the Minister say whether he has ascertained why these fire doors were not installed in No. 26 Colliery? And would he tell us whether it will be a requirement that fire doors be installed now in all Devco operations?

There's no doubt in my mind that if the belt lines (underground conveyors which transport the coal) had been properly cleaned and serviced and stone-dusted, (which reduces the likelihood of sparks igniting), 26 would not have had that fire.

comprehensive review of corporate operations which was announced by the Minister last week?

However, there are not many days left before the summer adjournment and we will try to reach an agreement with the Opposition to debate and approve this motion in the very near future unless the conditions laid down by the Opposition are so exaggerated that we cannot reasonably accept them as this would mean going against the other priorities of the Government.

CANADIAN RADIO-TELEVISION AND TELECOMMUNICATIONS COMMISSION

REGULATION OF LONG DISTANCE TELEPHONE SERVICE

Mr. David Orlikow (Winnipeg North): Mr. Speaker, my question is directed to the Minister of Communications. The Minister knows that Canadians are proud of the high quality and reasonable cost of their telephone service. I am sure he also knows that, as a result of deregulation of the telephone industry in the United States, local rates for U.S. residents and small business people have doubled and tripled. The CRTC is now going to consider an application by CN-CP Telecommunications to be permitted to compete with Bell Telephone for long distance telephone service. If its application is approved it will soon mean substantial increases in the monthly rates paid by consumers.
