wish to raise with the House. That co-operation is continuing at the moment and we may be able to complete the matter this afternoon. I would ask that I be able to defer raising this point of privilege until we have a chance to see if the government has been able to complete its work.

Mr. Speaker: I will take that into account. The hon. member may want to raise it again with me.

Ms. Barbara Greene (Don Valley North): Mr. Speaker, I rise with respect to the question of the member for Winnipeg North Centre yesterday in which he impugned the motivation of the Prime Minister in signing the UN Convention on the Child, the member misled the House when he stated that the Prime Minister had pre-empted the report so that he could have a photo opportunity.

I want the House to know that I decided last Tuesday morning, in conjunction with the standing committee, to table the report this morning because I felt it would be the best time. At no time did I plan to table the report on Wednesday, with the proviso that if the House did not sit on Thursday I might have tabled it on Wednesday.
