The following communication has been received by The Advertiser from Ald. F. E. Harley:

To the Editor of The Advertiser:

Letters appearing in the local dailies, signed in one case, "Rate Payers," and in the other "J. Tait," oppose the motor bus bylaw. As the letters signed "Rate Payers" and "J. Tait" are identical, and "J. Tait" is the secretary of the London Street Railway Company, this is not surprising. A quotation used by Mr. Tait to convey the impression that ten-cent fares will be necessary in London is taken from the Electrical Railway Journal, which might be considered biased.

The question of fares is, of course, important. It was intended to charge five-cent fares at the start, and a little thought will reveal the fact that the fare would be five cents, but whether or not, after a fair trial, a reduction might be possible depends upon the economy of operation and support given by the public to this service. In the event of the present system of fares, it would provide adequate transportation facilities, it is the duty of the council to have some substitute at hand, but experience in the past shows that such a condition of affairs is not improvable, and it is hoped that in a short time he will be able to ride his tricycle again, and not down a staircase.
