*Resolved,* That an humble Address be presented to His Excellency the Governor General, informing His Excellency that this House hath voted an humble Address to Her Majesty on the subject of the Local Governments and Legislatures of *Lower and Upper Canada* respectively, when the Union of the Provinces of *British North America* is effected, and praying that His Excellency will be pleased to transmit the same to Her Majesty's Principal Secretary of State for the Colonies, to be laid at the foot of the Throne.

*Ordered,* That the said Address be engrossed.

*Ordered,* That the said Address be presented to His Excellency the Governor General, by such Members of this House as are of the Honorable the Executive Council of this Province.

The Clerk of the Legislative Council delivered, at the Bar of the House, the following Message :—

The Legislative Council have passed the Bill, intituled, "An Act to incorporate the *Fenelon Falls, Minden, Haliburton and Northern Lakes Steam Navigation Company,*" with an amendment, to which they desire the concurrence of this House.

Also, the Legislative Council have agreed to the amendments made by this House to the Bill, intituled, "An Act to amend the Medical Act for *Upper Canada,*" without any amendment.

And also, the Legislative Council insist upon their amendments to the Bill, intituled, "An Act to amend the Act to amend and consolidate the provisions contained in the Acts "and Ordinances relating to the Incorporation of, and supply of water to, the City of *Quebec,*" for the following reasons :—

As to the amendment to sub-section eighteen of section twelve. Because the prescription of two years therein mentioned is a right which has accrued to the citizens under an Act made public by the Royal Assent, and which has been the basis of arrangements between the citizens, and it would be unjust to repeal the same.
