

Petitions presented.

The Honorable Mr. *Fergusson* presented two Petitions from the Municipal Council of the Township of *Puslinch*, praying for such an alteration in the Assessment Law as will enable the Corporations to assess all property according to its real value ;

And also, praying that the Clergy Reserves and Rectories may be sold, and the proceeds applied towards the support of Education and the maintenance of Public Works.
