C.P.R. Enterprise.

President Van Horne of the C. P. R. arrived in Winnipeg on Saturday the 19th accompanied by a number of gentlem on from Toronto, Montreal, Kingston and Hamilton. General Superintendent Whyte was also with the party. A Free Press reporter interviewel Mr Van Horne and obtained some information from him in regard to the improvements contemplated by the company this year. In reply to a question as to the object of the present trip, Mr. Van Horne said: "It is the annual inspection of the line. One object is to decide upon the various works proposed for the improvement of the line during the coming season A large amount of work is to be done between the Ottawa river and Winnipeg in the way of filling bridges with earth or replacing them with masonary and steel. By the end of the present year there will be very few timber structures left in the line between Winnipeg and Port Arthur, and by the end of next year probably not one will be left. By that time the entire line from Winnipeg to Port Arthur will have been re-laid with new steel rails, weighing 72 pounds to the yard. Three hundred and forty miles of the main line between Winnipsg and Montreal have been relaid with new 72 pound rails and hundreds of bridges have been filed or made permanent within the past two years. Extensive improvements are also contemplated in the mountain

section during the present and coming year, and very large additions will be made this year to the rolling stock to provide for the rapidly increasing business of the company. Sixty locomotives and a great many freight and passenger cars are already under order.'

In regard to the Souris branch he stated that the Souris branch will undoubtedly be extended during the present season to the coal. fields." Some additions will also be made to the Glenboro branch. He was then asked if the company sutended to build a bridge at Selkirk. To this he replied:

"There is no truth in the report about the Selkirk bridge. Nothing of the kind is contemplated at present. Our surveys from Selkirk had in view only the extension of the present Selkirk branch." In speaking of western enterprises he said : "The Calgary & Edmonton railway, which is to be worked by the Canadian Pacific when finished, will reach Edmonton this year and will probably be extended south from Calgary to McLeod, about 50 miles, next year." The question of the rumored purchase of the Northern Pacific's Manitoba branches by the C. P. R. was approached, but Mr. Van Horne declined to discuss it.

The party will go right through to the coast and on their way back will inspect the Prince Albert branch arriving in Winnipeg about May
