Resolution,—To increase salaries of Speakers and Deputy Speaker, and the sessional allowances of members of the Senate and House of Commons, etc.: House to consider in committee of the whole at its next sitting, 194-5. Motion, Mr. St. Laurent,—That Mr. Speaker do now leave the Chair, 218. Amendment, (Mr. Drew),—That the said item be not now considered but that the subject-matter thereof be referred to a royal commission, 218. Amendment ruled out of order, 218-9. Motion agreed to, and House in Committee of the Whole, 220. Resolution reported, 221. Bill No. 171, Mr. St. Laurent, An Act to amend the Senate and House of Commons Act; 1st R., 221. 2nd R., moved and debate adjourned, 245. Debate resumed; 2nd R. agreed to, (yeas 155; nays 45), 249-50. Considered in committee of the whole and reported with amendments, 257. 3rd R., moved and agreed to (yeas 153; nays 46), 282-3. Passed by Senate, 298. R.A., 318. (2-3 Elizabeth II, Chapter 10).
