Hon. Leon Balcer (Minister of Transport): Mr. Speaker, the management of Canadian National Railways advise as follows:

The relocation of the dispatching office and facilities will enable them to be located where the natural division of traffic occurs, with approximately 50 per cent moving between Prince George and Jasper and the remainder between Prince George and Prince Rupert. The location of the facilities at Prince George will simplify and result in more efficient handling of interchange traffic with the Pacific Great Eastern Railway at that point.

## FLOOD THREATS TO INDIAN RESERVES, GRAND RAPIDS DEVELOPMENT

# Question No. 232-Mr. Howard:

1. Is any Indian reserve threatened with flooding as a result of the Grand Rapids power development, and, if so, what is the name of each such reserve, its area, and the band membership?

2. What steps are being taken to provide compensation to the said bands for the loss of their land, and, if any price has been agreed upon, what is it in so far as each reserve is concerned?

3. Are any steps being taken to provide substitute reserve land for these bands, and, if so, what steps, and where will the new reserves be established, and what will be the acreage of each?

4. Are any arrangements being made to finance the movement of the band members to the new reserves, or any other place, and, if so, what are the details of these arrangements?

## Hon. E. D. Fulton (Acting Minister of Citizenship and Immigration): Mr. Speaker, the answers are as follows:

- 1. Yes, partially. Moose Lake reserve and Chemawawin reserve, which together comprise a total area of approximately 9,072 acres. The membership of the bands is Moose Lake, 185 and Chemawawin, 221.
- 2, 3 and 4. These matters are under discussion with the Manitoba department of mines and natural resources acting for the Manitoba hydroelectric board.
