The first is the usual reservation as to privileged documents and provincial consent; the second condition would be an understanding that the motion applies only to documents within the last two years; and the third condition would be that it applies only to federal-provincial and federal-municipal communications, not to provincial-municipal communications. I had a conversation with the hon. member on that subject and I believe he will agree.

Mr. Knowles: I can confirm that, Mr. Speaker.

Mr. Speaker: Subject to the reservation just expressed by the minister, is it the pleasure of the house to adopt the motion?

Motion agreed to.
