WHEAT—REPRESENTATIONS FROM SASKATCHEWAN AS TO PRICING

Right Hon. J. G. Diefenbaker (Prince Albert): Mr. Speaker, in the absence of the Minister of Industry, Trade and Commerce may I ask whether the Prime Minister, prior to March 26, received a telegram from the Premier of Saskatchewan setting out a resolution unanimously passed by the Saskatchewan legislature in favour of a floor price of \$1.95½ for wheat and a two-price system, with the price at Fort William fixed at \$2.12? What is the reaction of the government and the reply of the Prime Minister to that very reasonable request, having regard to the serious condition on the prairies today amongst wheat farmers?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, if I received such a telegram I probably referred it to the Minister of Agriculture to give me advice on how to answer it.

Mr. Diefenbaker: In the absence of all the absentees, Mr. Speaker, could I find out who is acting as Minister of Industry, Trade and Commerce, or possibly the Minister of Agriculture, with his all-pervasive knowledge, could answer the question?

Hon. H. A. Olson (Minister of Agriculture): Mr. Speaker, such a telegram was received and it is being considered.

Mr. Diefenbaker: Would the minister say whether there is any expectation that a decision will be made within the next couple of days, having regard to the approach of spring and the need of the farmers out west for funds, as the minister knows?

Mr. Olson: Mr. Speaker, as the right hon gentleman also knows, the two proposals that were contained in the telegram are in fact major new proposals in agricultural policy, and I am sure he would not expect the government to make that decision within two days.

Mr. Diefenbaker: Mr. Speaker, the government has had three weeks now. How much longer does it want to stay asleep concerning the plight of the farmers in the western provinces?
