POSSIBILITY OF FURTHER TAX CUTS FOR LOW-INCOME CANADIANS TO STIMULATE DEMAND AND PROVIDE JOBS

Mr. David MacDonald (Egmont): Mr. Speaker, I wish to direct a supplementary question to the Prime Minister. In light of the fact that the income tax bill as presently drafted is still before the House, and the stress by the Economic Council of Canada on increasing domestic demand, I wonder if the Prime Minister has conferred with the Minister of Finance and discussed with him the possibility of further tax cuts for low-income Canadians in order that there can be a greater stimulation of domestic demand to provide these much needed jobs in coming years?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I would be glad to discuss that with the minister when he returns from the Group of Ten meeting in Rome. In the meantime it would be helpful if the legislation presently before the House could be passed as it has the effect of reducing taxes on the low income groups.

UNEMPLOYMENT—DEVELOPMENT OF INDUSTRIAL POLICY TO UTILIZE SCIENCE GRADUATES UNABLE TO FIND WORK

Mr. David MacDonald (Egmont): Mr. Speaker, I wish to ask a further supplementary question. Perhaps I could preface it by saying that there has been no reluctance on the part of the Minister of Finance to bring in a number of amendments since the bill first came before the House. I would ask the Prime Minister whether, in view of the statement in the preliminary report of the Department of Manpower and Immigration on the requirements for university graduates in 1971, issued yesterday, that in 1971 the demand for Bachelor of Science graduates declined by 44 per cent and for Doctor of Science degree holders by 31 per cent, the government is giving consideration to this very serious situation, and is it taking the advice of the Science Council of Canada for the development of a new industrial policy that will utilize this growing number of highly skilled scientific manpower resources that are presently unable to find work?

Right Hon. P. E. Trudeau (Prime Minister): Yes, Mr. Speaker, there are many aspects of our industrial policy which are aimed with this in mind, and I am sure the

Minister of Industry, Trade and Commerce will send copies of his statements to the hon. member if the hon. member wants to look into them.

Mr. Speaker: Order, please. I mentioned a moment ago that there are a number of hon. members seeking the floor to ask supplementary questions. For the present the Chair will recognize the hon. member for Shefford and then return to further supplementaries on this subject.
