We must also encourage the participants in the Yalta Agreement to recognize and repudiate that agreement and then, can the 40 years of unjustice cease? At that time we might begin to see the beginning of a new era, an era of true peace in the world, without tension, where nations are truly free.

#### ACID RAIN—APPOINTMENT OF FORMER ONTARIO PREMIER AS CANADIAN ENVOY

## BROADCASTING POLICY REVIEW

**Ms. Lynn McDonald (Broadview-Greenwood):** Mr. Speaker, before returning to our ridings some of us will have the opportunity to attend the ACTRA Awards tonight, the only cultural awards in the world named after the creative people themselves, through their union, ACTRA.

Yet, with the Government's cut-back approach to cultural expenditure, especially for the CBC, we must wonder how many excellent programs will be produced next year.

The Minister of Communications (Mr. Masse) will be announcing his broadcasting policy review next week when the House is not sitting.

As arts and culture critic for the NDP caucus, I share the concern of the arts community, and indeed of a considerable cross-section of the Canadian public, that this review be genuinely open to public participation; include men and women of vision and knowledgeable of broadcasting, from all political Parties and regions, in both official languages; and invite the participation of the creative community, individually and through their unions and professional associations. This review should consider ways to stimulate and require more quality Canadian programming in the private networks and stations, address the real funding needs of the CBC, especially for long term planning, and consider the desirability of moving to commercial-free public broadcasting.

Excellence in broadcasting requires excellence in funding; our artists have had too excellent an acquaintance with poverty for too long. The Government must realize that the arts community will be judging the Government's performance, its excellence or otherwise, in May when it brings down its first Budget.
