PUBLIC NOTICE

The following Bylaw, relating to Street Parades and Processions, passed by the Board of Police Commissioners of the City of Toronto on the 26th ult., and now in force, is hereby published for the information of all concerned:

1. No procession or parade shall be allowed upon any highway unless at least twenty-four hours' notice in writing of the intention to hold the same is given to the Chief Constable, and to be effective such notice must state:

(a) The proposed route of the procession, and its destination; (b) Approximate number of persons forming the procession, stating: Number on foot; number mounted; number of bands of music; number of carriages.

2. On streets upon which there are car tracks, the procession must march on the right-hand side of the roadway, leaving room for other traffic, and must not obstruct the roadway or the sidewalks.

3. The procession shall cause no unnecessary interruption to the street car or other traffic, and must obey the directions of the police constables as to allowing street cars or other traffic to pass through the procession.

4. Persons in charge of street cars, or other vehicles, and other persons upon the highway, shall obey the directions of the police constables as to stopping, or as to passing through the procession, and persons in charge of vehicles (other than street cars), and pedestrians shall obey the directions of the police constables as to the routes to be followed.

5. The above regulations requiring notice to be given shall not apply to processions of persons less than fifty in number.

6. The Chief Constable may, if he deems it expedient and necessary, require the procession to take a different route from that indicated in such notice, and the procession shall adhere to the route approved by the Chief Constable.

7. At the intersections or other frequented portions of the highways, on all occasions or times, when the procession is passing through the police constables are authorized and directed to order or direct the procession to stop or to pass through the procession.
