## THE STAR GAME.

As we suspected The Evening Star had in mind the other evening the turning of the tube proposals. Last night the street railway organ came out quite openly and declared that The World wishes to starve the suburbs, and had made a bogey of the Rosedale proposals, and committed other enormities which are summed up in opposition to the street railway designs.

The World has never suggested for a moment the starvation of the suburbs. It believes that the only adequate suburban service for the city must be rendered by a direct tube service with feeders from the various suburban localities lying adjacent. An all-surface system such as The Star advocates must be a feeder of the street railway, must tend to congest the already congested down-town traffic still further, and what is of still more importance to the citizens, involves a new agreement with the street railway covering the services in the new territory.

This is, of course, what The Star and its friends want. It is for this that it misrepresents the attitude of The World. It is for this that it argues that a service which will take 45 or 55 minutes to bring passengers from the suburbs to the city centre, is what Toronto needs, while it tries to make people believe that a service which would bring them down town in a third of the time would be starving the suburbs.

What the street railway wants and what The Star would like to have the way for is a new agreement with the city. The citizens will have a vote upon that, however, and this is a point The Star cannot surmount by misrepresentation.

Tubes as soon as possible is the city's policy.

## MEN WHO KNOW AND OTHERS.

Any self-respecting engineer would be expected to resign after the way the board of control dealt with the letter City Engineer Rust sent to the board giving his views upon the state of the water in the old five-foot pipe. The controllers are determined to bring the pipe into service, and thus compel the citizens to drink or otherwise consume the stagnant water with which it is filled.

However, it has been customary for the city council and the permanent officials to act without any regard to each other, and the engineer is usually justified by time and a succeeding council. The fact is that the engineers who resigned when the council undertook to know better were unable to remain in the city service any length of time.

Mr. Rust appears properly to have gauged the calibre of the men with whom he has to deal. He knows that he knows better than they, and that their affronts chiefly redound to their own discredit.

## GET THE STATUS OF THE RADIALS.

The first thing for the new counsel of the city re street railway matters will be to ascertain the status of the five radial lines that are now on streets within the city, besides the Toronto Railway Company. They claim to have all kinds of privileges. A little examination by a legal expert will shatter some of these. To begin with, they've all got nothing more than a single track franchise, and all more or less conditioned.

But the city must pay a big salary to a big man as counsel. Get the best. Mr. Mabee of the railway commission or Mr. William Meredith is the kind of man.

## NO SIGNS.

There should not be the slightest hesitation on the part of the assessment commissioner about throwing out the application sent on to him for approval by the island committee for permission to erect a sign on city property on the island. No sign should be allowed on city property anywhere. There are too many signs now, and while other cities are striving to eliminate them, it is absurd for Toronto to begin breaking through an established principle.

An effort is being made to curb the commercial signs on the leading thoroughfares, and this has been done to some extent. The proposal to disfigure the city parks with starting, glaring, glaring signs is altogether out of the question. Ald. Baird, who is chairman of the island committee, ought to remember that he belongs to a big city now, and not a village, and should act with some regard to the traditions that a city of the size of Toronto is expected to follow.

The usual arguments will be advanced which are always available when interested parties want favors, but the city as a whole must be considered, and there are signs enough now in the streets without having them obtruded

on the tired eyes of those who seek the solution of the parks.  
The question of beauty is an obvious one, but our utilitarian rulers are not always amenable to such arguments. The argument they will understand is the fact that people do not want the signs in the parks. The assessment commissioner will make no mistake in saying no to the request.

All the world is watching the result of the United States' attempt to bluff Canada. Surrender now will lose the Dominion an advantage hard, if ever, to be regained.

## STEP TOWARDS CONCILIATION

Railway Brotherhoods Name J. G. O'Donoghue as Arbitrator.

For months the conductors' and trainmen's associations or brotherhoods have been negotiating with the C.P.R. G.T.R. and Wabash (Canadian division) companies for a settlement of their grievances, but as yet nothing has been accomplished. A further step towards conciliation has been made, however, and it has been decided by all parties to have the question of differences settled by a conciliation board. Only one representative on that board has been appointed yet. He is J. G. O'Donoghue, who will represent the conductors and trainmen. No representative for the railway companies has been named. The time and place of meeting has not been fixed, but in all probability the board will hold their deliberations in Montreal.

The men are demanding an increase in wages, better hours and better conditions generally. What increase they wanted Mr. O'Donoghue was unable to tell.

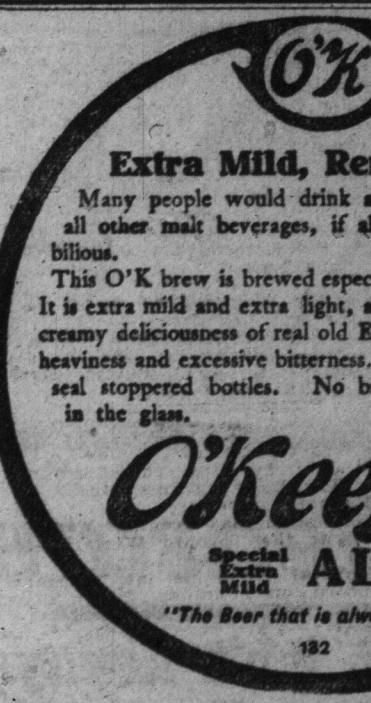

## WON FROM CANADA AND EMPIRE

Young Halifax Barrister Awarded Hundred Guinea Prize.

HALIFAX, March 23.—Reginald O. Harris, barrister, of Messrs. Harris, Henry, Stairs and Harris, of Halifax, has been declared the winner of the 100 guinea prize offered by Chris Brittan, M.P., for the Standard of Empire of London.

Mr. Harris is but a young man; had the keen competition among fellow-Canadians of such men as Messrs. Castelli Hopkins and Rev. H. T. F. Duckworth (Trinity College), Toronto, and W. H. Lightbail, K.C. of Montreal.

A. P. Joseph of Quebec, etc., but his essay on "The Governance of the Empire" won out. Mr. Harris is secretary of the Liberal-Conservative party of Nova Scotia, and a nephew of Robert E. Harris, K.C., the president of the Nova Scotia Steel Co.
