which are unparliamentary, so I cannot accept the question of privilege of the hon. member. It is the impression of the Chair that there is not unanimous consent to suspend private members' hour.

Mr. Peters: Mr. Speaker, I would like to withdraw the request I made. I had the impression that the hon. member for Scarborough East (Mr. O'Connell) had remained in Toronto due to travel difficulties. I was surprised when I saw him after I made the request. I did not expect the hon. member would be here to sponsor Bill C-1001, so I assumed we could go ahead with Bill C-11.

Mr. O'Connell: Mr. Speaker, I appreciate the comments of the hon. member and I am pleased that he will withdraw his suggestion, but I have been in the House this afternoon.

Mr. Peters: I am sorry; I did not see the hon. member.

Mr. Symes: A question of privilege, Mr. Speaker—

Mr. Deputy Speaker: I hope it is not related to the point we have just disposed of.

Mr. Symes: Mr. Speaker, the hon. member for Scarborough East (Mr. O'Connell) accused hon. members in my party of conducting a filibuster. I dispute that. That has a negative overtone which Your Honour said was not there. My definition of the word "filibuster" is "deliberate delay". We are examining the bill and bringing out our criticisms of it. I do not think that should be complained about.

Mr. Deputy Speaker: In my opinion the hon. member's remarks demonstrate that the Chair was right. The hon. member is disputing the point of view of another hon. member. What I said was that although the remarks of the hon. member for Scarborough East might have been interpreted as a reflection upon hon. members, in my judgment it was not a reflection imputing motives. In my mind, and I am sure in the minds of hon. members, words used in debate blaming other hon. members of delaying legislation have been used very regularly in this House. Perhaps using the word "filibuster" might not be pleasant—

Mr. Rodriguez: Terrible; absolutely shameful.

Mr. Deputy Speaker: —or one of the best of our parliamentary practices, but I feel that the point raised by the hon. member does not represent a question of privilege.
