

in, Mr. Speaker resumed the Chair; and Mr. *Mackenzie* reported, That the Committee had gone through the Bill, and directed him to report the same, without any amendment.

Mr. *Wright* (East York) moved, seconded by Mr. *McKellar*, and the Question being proposed, That the Bill be now read the third time;

The Honorable Mr. *Macdonald* (Cornwall) moved, in amendment to the Question, seconded by Mr. *Walsh*, That the word "now" be left out, and the words "this day three months" added at the end thereof;

And the Question being put on the amendment; the House divided:—And it passed in the Negative.

Then, the main Question being put;

Ordered, That the Bill be now read the third time.

The Bill was accordingly read the third time.

Resolved, That the Bill do pass, and the title be, "An Act to amend and consolidate the Acts to impose a Tax on Dogs, and to provide for the better protection of Sheep in *Upper Canada*."

Ordered, That the Clerk do carry the Bill to the Legislative Council, and desire their concurrence.

Then, on motion of the Honorable Mr. Attorney General *Macdonald*, seconded by the Honorable Mr. Attorney General *Cartier*,
The House adjourned.

Pursuant to the Order of the Day, the following Petitions were read:—

Of the Board of Trade of the City of *London, Canada West*; praying that no alteration may be made in the Banking Currency of this Province.

Of the Mayor, Aldermen and Commonalty of the City of *London, Canada West*; praying that the Bill respecting Municipal Institutions in *Upper Canada*, and the Bill respecting the Assessment of Property in *Upper Canada*, may not become law.

Of *O. L. Richardson* and Sons, and others, of the City of *Quebec*; praying for amendments to the Bill respecting Duties of Customs, in relation to Leather and Raw Hides.

Resolved, That this House doth concur in the Seventh Report of the Joint Committee of both Houses on the subject of the Printing of the Legislature.

On motion of Mr. *Jones* (North Leeds), seconded by Mr. *Shanly*,

Ordered, That the Report of the Select Committee appointed to obtain information as to the extent and resources of the Copper Mines on the North Shore of *Lake Superior*, &c., be printed for distribution, notwithstanding the Report of the Joint Committee on the subject of the Printing of the Legislature.

Ordered, That the Fee paid on the Bill to amend certain errors in a Conveyance from one *Alexander Dixon*, deceased, in his lifetime, to *William Montague Westmacott*, bearing date the first day of September, A.D. 1864, and to confirm a sale of certain lands thereunder, be refunded.

The Honorable Mr. *Cameron* reported the Bill to amend and consolidate the several Acts respecting the Municipal Institutions of *Upper Canada*; and the amendments were read, and agreed to.

Ordered, That the Bill be now read the third time.
