FREIGHT RATES REDUCTION ACT

AMENDMENTS EXTENDING APPLICATION AND INCREASING EXPENDITURES

Hon. Leon Balcer (Minister of Transport) moved that the house go into committee to consider the following resolution:

That it is expedient to introduce a measure to amend the Freight Rates Reduction Act to extend for not more than twelve months the period during which the revised rates under the said act shall be applicable and to increase the authorized expenditure under the act by an additional twenty million dollars.

Motion agreed to and the house went into committee thereon, Mr. Chown in the chair.

Mr. Balcer: This resolution seeks the approval of the house to introduce a bill to amend the Freight Rates Reduction Act for a further period not exceeding 12 months from April 30, 1962, and to provide necessary money for that purpose.

The original Freight Rates Reduction Act was passed in 1959. Its purpose was to make provision for a reduction in certain freight rates that were taking the 17 per cent freight Churchill (Minister of rate increase which had been authorized to Veterans Affairs): No, Mr. Speaker.
