CANADIAN WHEAT BOARD ACT

MINISTER, POWERS OF BOARD, ETC.

STEVEN TRUSCOTT

PROVISION FOR IMMEDIATE GRANTING OF PAROLE

Mr. Stanley Knowles (Winnipeg North Centre) moved for leave to introduce Bill No. C-107, for the parole of Steven Murray Truscott.

Some hon. Members: Explain.

Mr. Knowles: Mr. Speaker, the purpose of this bill as its title indicates is to give parliament an opportunity to express its will that a parole be granted forthwith to Steven Truscott. The bill does not dispute the opinions or decisions of the courts in respect of either the question of guilt or innocence, or the right of Steven Truscott to a new trial. However, it would grant him an immediate parole without prejudice to his right to continue to seek a new trial or to pursue any other legal course available to him.

EXTERNAL AFFAIRS

SPEECH OF PRIVY COUNCIL PRESIDENT ON VIET NAM-MOTION FOR ADJOURNMENT UNDER STANDING ORDER 26

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, before the orders of the day are called I wish to move a motion. Unfortunately I was unable to secure the translation into French, and I offer my regrets to the house. It is the first time this has happened to me, but the translation was not returned to me in time. I move, seconded by the hon. member for Winnipeg South Centre (Mr. Churchill):

That the house do now adjourn under standing order No. 26, on a matter of urgent public importance, namely the crisis in international confidence brought about by the speech of the President of the Privy Council on Saturday last in Toronto, which constitutes a public declaration of policy of the gravest national and international significance in that it gives the greatest of encouragement to the communist world and reveals deep enmity toward the policy of the United States administration with regard to the war in Viet Nam, and will result in further and accelerated deterioration in Canada's relations with the U.S.A.; and furthermore, is a travesty on this house which has been denied the enunciation of policy of the government which was made in the said speech outside of this house while parliament is sitting.
