APPOINTMENT OF MEMBERS TO TRIBUNAL

Mr. A. D. Hales (Wellington South): Mr. Speaker, I should like to ask the Minister of Finance whether he can advise the house as to when he proposes to appoint the final two members to the anti-dumping tribunal?

Hon. E. J. Benson (Minister of Finance): Mr. Speaker, they will be appointed as work develops for the tribunal. I understand that to date there has been only one case referred, and the members we now have are adequate for the work load. The idea is that as the work load increases we will extend the board membership to five members.

Mr. Hales: If it becomes necessary to increase the board membership to five, can the minister assure the house that the other two appointments will be given to well experienced businessmen?

Mr. Benson: Mr. Speaker, I should like to say that I believe the appointments to this board are men of as high calibre as any board we have in Canada. I have great confidence in every person appointed to this board.

## POSSIBILITY OF EXTENDING ASSISTANCE PROGRAM

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, last Wednesday I asked the Minister of Transport in his capacity as Acting Prime Minister whether the government's review of Canada's foreign policy included a study of the possibility of increasing our activities under our external aid program. The minister said he would draw this important question to the attention of the Prime Minister and the Secretary of State for External Affairs. I expressed the hope that there might be a statement on this matter this week, and I wonder whether it is now ready?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, the answer to the specific question is yes. This is part of the government's review of foreign policy, and we are considering both the quantity and the quality of our foreign aid.

Mr. Knowles (Winnipeg North Centre): Would the Secretary of State for External Affairs indicate when it is expected that Canada will reach the target of 1 per cent of our gross national product in respect of foreign aid?

Mr. Sharp: I cannot be precise, Mr. Speaker, but like the Minister of Finance, I should like to say "as soon as possible."
