NATO—DISCUSSIONS RESPECTING MOVE OF HEADQUARTERS

On the orders of the day:

Hon. Marcel Lambert (Edmonton West): My question is for the Secretary of State for External Affairs. During the visit in Ottawa, of the right hon. Mr. Brown, Foreign Secretary of Britain, was there a discussion with him concerning the changed position by Canada with regard to moving the permanent base of NATO from Paris to Brussels? If so, what was the result of the discussion?

Hon. Paul Martin (Secretary of State for External Affairs): I did have a discussion at the United Nations with Mr. Brown about a number of matters, including that particular situation. I advised him what the position of the Canadian government was at that time.

Mr. Lambert: May I ask a supplementary question? Will the minister advise the house whether the position of the Canadian government has changed in regard to this, and whether it is accepting the representations from fellow NATO nations that a move should be made from Paris to Brussels?

Mr. Speaker: Order. It seems to me that this question is of a very general nature and is not the type of question that could be answered simply at this time.

Mr. Lambert: I will rephrase it, then. Has the minister changed his position, and is he prepared to accept the recommendations to move from Paris to Brussels?

Mr. Martin (Essex East): There is a matter that has to be decided by the council of the alliance. There was to be a discussion in the council today, but that discussion has been postponed. Consultations on this question are now taking place between Canada and its partners.
