HOUSING OWNED BY CMHC

Question No. 1.793-Mr. Godin:

1. Throughout Canada, how many (a) single family dwellings (b) semi-detached duplexes (c) apartment buildings (d) rental housing are owned by Central Mortgage and Housing Corporation?

2. How many dwelling units are involved in such dwellings or buildings and what is their total value?

3. How many dwellings or buildings of each category had to be repossessed by CMHC over the past five years, owing to contractors' bankruptcies?

4. In each province what is the total value of all dwellings and buildings seized under such circumstances and at what civic address are these houses or buildings located?

Hon. Ron Basford (Minister of State for Urban Affairs): 1. Central Mortgage and Housing Corporation keeps it records on the basis of the number of housing units, all of which are for rental purposes. The number owned by CMHC or administered by it on behalf of various insurance funds, under the National Housing Act as December 31, 1972, are given in the table following:

CORA BROWN AND McDONALD SUBDIVISION— OBJECTIONS TO EXPROPRIATION

Question No. 1,847-Mr. Reynolds:

- 1. Is it the intention of the Minister of Public Works to table all the transcripts of objections to the expropriation of the Cora Brown and McDonald Subdivision and, if so, on what date?
- 2. Did the Minister accept any recommendations and, if not (a) for what reasons (b) were the people involved so informed?

Hon. Jean-Eudes Dubé (Minister of Public Works): 1. No. The Hearing Officer's report was tabled April 2, 1973 and summarizes the objections. Therefore it is not considered necessary to table the transcript, which is quite voluminous and for which translation and tabling procedures would be costly and time-consuming. The transcript is available in the department and may be examined by arrangement.

2. No recommendations were made in the Hearing Officer's report and none is required by the Act, the duties of the Hearing Officer and the nature of his report were explained to the people who were present at the Public Hearing. The two main objections were: (a) That the municipally-owned boat launching site not be expropriated; (b) That extensive environmental studies be carried out before building a new runway. Both of these objections were satisfied. The boat launching site was not expropriated and a complete study of the effects of a new runway is being made.

- 1. Was a Minister's permit issued to enable Mr. Paul Mason to enter Canada?
