AGRICULTURE**SUBSIDY TO BEEF PRODUCERS—REQUEST FOR UNANIMOUS
CONSENT TO MOVE MOTION**

Mr. Léonel Beaudoin (Richmond): Mr. Speaker, I rise under the provisions of Standing Order 43 to ask the unanimous consent of the House to discuss a matter of urgent and pressing necessity.

In view of the fact that the government admits that the prices paid to meat producers are too low at the present time and that it will give a 7 cents a pound subsidy to the producers to compensate for the low price of beef, I move, seconded by the hon. member for Bellechasse (Mr. Lambert):

That the Minister of Agriculture reconsider the subsidy given by his department so that this subsidy may be granted in such a way as to benefit the producers, contrary to the present one which is much more profitable for the dealers than for the producers, and that this may be done in the same manner as the program once implemented for pork producers, in other words, that the government subsidy go directly to the beef producers.
