#### THE CANADIAN ECONOMY

SUGGESTED RECONSIDERATION OF BUDGETARY MEASURES WHICH AFFECT CONSUMER PRICE INDEX IN VIEW OF INCREASE

Mr. James A. McGrath (St. John's East): Mr. Speaker, may I direct a question to the Minister of Finance? Considering the impact the 1.5 increase in the Consumer Price Index announced today by Statistics Canada and the government's budgetary thrust will have on low income earners and pensioners in Canada, and as the Conference Board of Canada predicts that the budget will raise the Consumer Price Index an additional 1.7 per cent, will the minister reconsider some budgetary measures which weight so heavily and cruelly on the poor and pensioners of this country?

Hon. John N. Turner (Minister of Finance): Mr. Speaker, we are all disturbed by the abrupt increase shown by the price index this morning. Three fifths of the increase is directly attributable to the higher prices of food products, particularly to the 18 per cent increase in beef prices. As for the budgetary policy of the government, that is currently before the House and was set forth two weeks ago.

Mr. McGrath: A supplementary question, Mr. Speaker. As food prices have increased substantially, something to which the minister alluded, the increase of 3.3 per cent last month being the largest increase in three years, and as, under the government's current budgetary proposals now before the House, unemployment insurance benefits for low income earners are to be reduced and old age pensioners are to be eliminated from unemployment insurance rolls, their incomes thereby being substantially reduced, what measures is the minister prepared to consider, in view of the substantially increased price of food, in order to bring relief to pensioners and low income earners of this country?

Mr. Turner (Ottawa-Carleton): Mr. Speaker, I do not accept the preamble to the hon. gentleman's question. He is fully entitled to argue it in debate.

Mr. McGrath: Mr. Speaker, fortunately the people of Canada do not accept the minister or his budget.
