# VETERANS AFFAIRS—PRINCE EDWARD ISLAND—POSSIBLE LOSS OF UNEMPLOYMENT INSURANCE BENEFITS

#### Ouestion No. 268-Mr. Herbert:

Will a unilingual French-speaking spouse of a Department of Veterans Affairs employee who moves to Prince Edward Island lose any unemployment insurance benefits because of the inability of that person to speak the English language?

Mr. Dennis Dawson (Parliamentary Secretary to Minister of Employment and Immigration): A claimant does not lose the right to unemployment insurance benefit by the mere fact of not speaking the language of the majority of the population in the area where he or she resides. What has to be determined is the person's availability, taking into account all the factors affecting it, including local labour market conditions. For example, a unilingual French person could quite conceivably work in an English-speaking environment, if the work required little or no knowledge of English.

It is the guiding principle that is at issue here. Each case must be studied separately, in the light of the facts, by the local benefit entitlement officers.
