GESTAPO AND NAZI PARTY MEMBERS

Question No. 2,250—**Mr. Blackburn:**

1. How many (a) former (b) suspected SS, SD, Gestapo and Nazi party members (i) entered Canada after World War II (ii) took up permanent residence?

2. Were former SS, SD, Gestapo or German Nazi party members arrested, charged or deported from Canada since 1945 and, if so, how many and what were their names?

3. Are attempts being made to track down and/or prosecute former SS, SD, Gestapo or German Nazi party members living or suspected of living in Canada?

Mr. David Smith (Parliamentary Secretary to President of the Privy Council): I am informed by the Department of Justice Canada and Employment and Immigration Canada as follows:

1. Canada did not admit for permanent residence any person who admitted or was suspected of having an affiliation with the organizations mentioned. There is no way to determine the number of persons who may have been admitted to Canada without knowledge of such an affiliation.
