# AUDITOR GENERAL'S REPORT—COMMENT ON PROPOSED LEGISLATION

Mr. Arnold Malone (Crowfoot): Madam Speaker, in light of the fact that the Auditor General of Canada has proclaimed that Government auditors are frequently denied access to information required to judge whether Government money in Crown corporations is being spent with regard and respect for economy, and since the Auditor General of Canada, Kenneth Dye, has stated that he sees more merit in the previous Crown Corporation Bill introduced in 1979 by the Progressive Conservative Party under the leadership of the Right Hon. Member for Yellowhead (Mr. Clark), and claimed that that Bill "had an effective framework for the control, direction and accountability of Crown-owned corporations", and since Auditor General Dye further proclaimed that the present Liberal Government's Crown Corporation Bill "advances no provisions dealing with the audit of Crown-owned corporations", I move, seconded by the Hon. #### APPLICATION TO SASKATCHEWAN PUBLIC SERVANTS

Mr. Van Mulligan had spoken out in opposition to the provincial Government's restraint program in the course of doing the job he was elected to do on Regina City Council.

The Premier of Saskatchewan has since gone on to declare that each and every Government employee who also serves his or her community on school boards, hospital boards, and even on church boards, must carefully weigh the consequences of freely speaking their minds in public.
