### **FUEL CONSUMPTION SURVEY**

## Ouestion No. 299-Mr. Cook:

- 1. Were any drivers approached to participate in Statistics Canada's Fuel Consumption Survey and, if so, how many?
- 2. Is there a publication entitled *Fuel Purchase Diary* and, if so (a) how many copies were printed and assembled (b) what was the unit cost of the publication (c) were any copies of the publication distributed and, if so (i) how many (ii) at what cost?

# Hon. Charles Lapointe (Minister of Supply and Services): Statistics Canada reports:

- 1. The Fuel Consumption Survey is a monthly survey conducted by Statistics Canada under contract to Transport Canada. For cars, light trucks and vans used for personal purposes, the survey collects information on characteristics of the vehicle, details of fuel consumed and factors which impact on this consumption. Approximately 1,780 vehicles are sampled per month and the principal driver of the vehicle is requested to provide details of all fuel purchases and corresponding odometer readings during the one-month reporting period.
- 2. The Fuel Purchase Diary is the data collection document provided to the respondent and in which the respondent is requested to record basic information about the vehicle and details of each fuel purchase made. One copy of this diary is mailed to the principal driver of each of the 1,780 sampled vehicles per month. The unit cost of the diary is approximately \$1.50 for a corresponding total monthly cost of \$2,670.
