Hon. Michael Wilson (Minister of Finance): Mr. Speaker, I think the Hon. Member would be the first to agree with me when I say that, if the Liberals had been in power, they probably would have gotten nothing.

Mr. Wilson (Etobicoke Centre): Let me remind him of the formula which I announced in the House vesterday. I said that we would be equitable in applying a 95 per cent floor to the three provinces which would not be receiving the same amount of equalization in the current fiscal year. Since I think he is comparing the Province of Quebec with the Province of Manitoba, I would remind him that Manitoba, without any changes in the equalization payments, will see its amounts go from 480 to 408 to 367 under the formula which the Liberals introduced in 1982. This is why the Province of Manitoba is being treated somewhat better in terms of the absolute amount which has been provided under the supplementary payments.
