#### CHALLENGE '85 PROGRAM—INCREASED STUDENT EMPLOYMENT

Mr. Jim Edwards (Edmonton South): Mr. Speaker, I rise today to commend the Minister of Employment and Immigration (Miss MacDonald), private business throughout the country, and provincial Governments for their roles in what has turned out to be an exceedingly successful summer job program—Challenge '85.

In my constituency of Edmonton South 386 jobs were created from the 171 projects funded under Challenge '85. Some \$956,000 was spent to employ students in Edmonton South.

The Challenge '85 package of programs is a comprehensive plan designed to provide career-related summer employment for people moving through the educational system. The success of this program cannot be underestimated. Throughout Canada, students and employers applauded the program. Students found it easier to obtain work related to their studies through the student employment offices. Employers found the program to be an excellent way to hire younger talent eager to work for them. This was the first time that Provinces collaborated with the Government in a job strategy for students.

The program resulted in a much improved employment picture in 1985 over 1984. Throughout Canada we created 14,000 more jobs for students than last year. A total of 100,020 jobs were created this summer. This success was reflected in the youth unemployment rate which fell from 18.3 per cent in August of 1984 to 15.9 per cent in August of 1985.
