That Bills C-206, C-207, C-241, C-318, C-325, C-348, C-399, C-400 and C-402 be discharged and the subject matter thereof referred to the Standing Committee on Justice and Legal Affairs.

Mr. Paproski: That is so agreed, Mr. Speaker.

Mr. Knowles (Winnipeg North Centre): We also agree to this motion.
