## Carriage of Mails between Lévis and Montreal-Grand Trunk.

AUDIT OFFICE, OTTAWA, January 19, 1899.

SIR,-It appears from the vouchers sent me in support of the expenditure during the fiscal year 1897-98 for mail service by railway, that the Intercolonial Railway was paid a mileage rate between Lévis and Montreal over the Drummond County road, from February 20, 1898.

I presume that the through mails from the maritime provinces, or at least that portion of them previously sent over the Intercolonial to Lévis were from this date carried

direct to Montreal without transfer at Lévis to the Grand Trunk mail cars.

The change thus effected in the transport of the eastern mails westward must have relieved the Grand Trunk of the greater portion of its mail service between Lévis and Montreal, but I do not find that any corresponding deduction has been made in the mileage rate over the portion of the line affected.

I bring this matter to your notice because it seems to me the rate at which payment is now made—\$160 per mile per annum—must be exorbitant, if it was only a fair and reasonable remuneration when the through mails had to be provided for and carried to Montreal.
